

ARTICLES OF INCORPORATION
OF
PASADENA BAPTIST CHURCH, INC.
(A Corporation Not For Profit)

We, the undersigned, with other persons being
desirous of forming a corporation exclusively for religious
purposes, under the provisions of Chapter 617 of the Florida
Statutes, do agree to the following:

ARTICLE I. NAME

The name of this corporation is PASADENA BAPTIST
CHURCH, INC.

ARTICLE II. PURPOSES

This corporation is organized to worship God, to
proclaim the Gospel of our Lord Jesus Christ, to provide
education about the Christian faith and life, to minister
to the spiritual and physical needs of people and to provide
for fellowship among its members.

ARTICLE III. MEMBERSHIP

1. Anyone who has accepted Jesus Christ as personal
savior and followed Him in baptism qualifies for membership in
this corporation. Members are admitted by application to the
membership committee and approval of members.

2. All members of THE PASADENA BAPTIST CHURCH OF
ST. PETERSBURG on the date these Articles become effective
shall continue as members of this Corporation subject to the
membership provisions of the By-Laws.

ARTICLE IV. EXISTENCE

This corporation shall exist perpetually.

ARTICLE VIII. BY-LAWS

The By-Laws of this Corporation shall be made, altered or rescinded by the members.

ARTICLE IX. AMENDMENTS

These Articles of Incorporation may be altered, amended or rescinded by the members at any regular or special business meeting provided that a notice stating the proposed change and the time and place of the meeting where the same will be considered has been given verbally in the Sunday morning worship service, printed in the Church bulletin and mailed to all active members at their address of record on the Church membership rolls, at least two (2) weeks prior to such meeting.

ARTICLE X. NON-PROFIT

This Corporation shall not carry on propaganda, or otherwise act to influence legislation or participate in political campaigns as a substantial part of its activities.

No part of the income of the corporation shall be paid or inure to the benefit of any person but the corporation shall be authorized to pay reasonable compensation for services rendered and may confer benefits upon its members in conformity with its purposes.

ARTICLE XI. TAX EXEMPT STATUS

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code (or the corresponding provisions of any future U. S. Internal Revenue Law) or by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code (or the corresponding provision of any future U. S. Internal Revenue Law.)

ARTICLE XII. DISTRIBUTION OF ASSETS


No person, firm or corporation shall ever receive any dividends or profits from the undertakings of this corporation and upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501 (c)(3) of the Internal Revenue Code (or the corresponding provision of any future U. S. Internal Revenue Law), or to the Federal government or to a State or local government, for a public purpose.

ARTICLE XIII. REGISTERED AGENT


