ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION AND BY-LAWS OF SYRIAN AMERICAN CLUB OF ORLANDO, INC.

1. With respect to purpose, the Articles of Incorporation and By-Laws of **SYRIAN LEBANON AMERICAN CLUB OF ORLANDO, INC.**, a Florida corporation (Charter No. 739763), are hereby amended to state the following:

The Syrian Lebanon American Club of Orlando, Inc., is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Consistent with these purposes, the organization's activities will consist of supporting or benefitting St. Jude's Children's Research Hospital and American Lebanese-Syrian Associated Charities, Inc., for so long as those organizations qualify as public charities under section 509(a)(1) or 509(a)(2) of the Internal Revenue Code, or such other public charities as may in the future be designated.

The foregoing Amendment was adopted by a two-thirds majority vote of all of the entire membership at large of this Corporation at a meeting on November 11, 1999, held pursuant to due notice.




