

# AMENDMENT TO THE ARTICLES OF INCORPORATION OF

## FRIENDS OF THE NEW SMYRNA BEACH REGIONAL LIBRARY, INC.

#### **FIRST**

This nonprofit was originally incorporated July 22, 1977, under the laws of the State of Florida, as The Friends of the Brannon Memorial Library, New Smyrna Beach, Florida, Inc., State of Florida document number 739925.

Subsequently the name was changed and now is and shall be Friends of the New Smyrna Beach Regional Library, Inc. The FEI number is 592504339.

Now therefor, the Articles of Incorporation are hereby amended to make modifications as follows.

#### SECOND

The principal office of the corporation shall be in the public library at 1001 S. Dixie Freeway, in the City of New Smyrna Beach, Volusia County, Florida.

#### THIRD

This corporation is organized for and will be operated exclusively for charitable, educational and literacy purposes through programs of or for the benefit of the New Smyrna Beach Regional Library, for literacy programs for children and for scholarships for graduating high school seniors within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

These purposes will include, but shall not be limited to:

- 1. Generating funds for the benefit of the library, to supplement funding by governmental entities, by acting as a recipient for donations, gifts and bequests by individuals or groups intended for the benefit of the New Smyrna Beach Regional Library programs, childhood literacy and scholarships by conducting sales of donated books and by other activities with the same intent.
- 2. Encouraging wider use of the library by the community to increase literacy, to provide cultural and educational enrichment and to encourage childhood literacy programs for children.
- 3. Promoting community interest, appreciation and support of reading and the library's programs.
- 4. Encouraging professional development of library staff by financially supporting their participation in conferences, seminars and related studies.
- 5. Encouraging public participation as unpaid volunteers with the Friends of the New Smyrna Beach Library.

The organization shall not, as a substantial part of its activities, attempt to influence legislation or participate to any extent in a political campaign for or against any candidate for public office.

#### **FOURTH**

All persons supporting the purposes of this corporation shall be eligible for membership and will be admitted upon payment of membership dues.

#### FIFTH

A Board of Directors comprised of no less than 3 and no more than 11 elected members will be responsible for managing the affairs of this corporation.

A Treasurer and Assistant Treasurer will be chosen by the Board of Directors and be responsible for the financial records of the corporation

The Board of Directors shall meet periodically to conduct the business of the corporation. Members of the Board shall serve for a two year term or until a biannual election of the Board of Directors is held. Current members of the Board of Directors may run for re- election. New members of the Board of Directors may be elected when an opening occurs.

#### SIXTH

The Bylaws of this corporation are to be made, altered or rescinded by the Board of Directors of this corporation.

#### SEVENTH

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in THIRD Article hereof.

#### **FIGHTH**

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

### NINTH

Amendments to these amended articles of incorporation may be proposed by resolution adopted by the Board of Directors and presented at a regular or special meeting of the members of this corporation. Amendments may be adopted by a vote of a majority of the members of the corporation present and voting.
