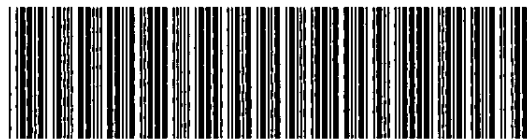

Article X, "Amendment of Articles" is amended to read as follows:


Article X

These Articles may be amended by an affirmative vote of two-thirds (2/3rds) of the votes of those members present at a meeting of the membership where a quorum is established.


The date of the adoption of the amendment was June 16, 2012.
