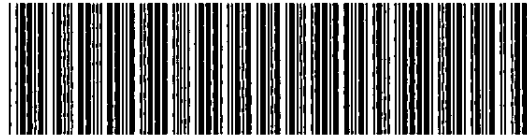

Article X, "Amendment of Articles" is amended to read as follows:


Article X
