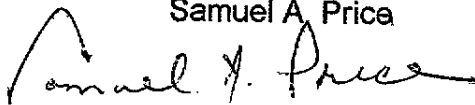

We the undersigned, being the President and Secretary of JESUS SUPERNATURAL DELIVERANCE CHURCH, INC., a Florida corporation Not for Profit, hereby certify that the following Amendments to the articles of Incorporation was duly adopted unanimously by all of the Directors and all of the members present at a meeting duly held by them on October 4, 1998.

AMENDMENTS

1. **Article VII (Board of Directors)** is amended to read as follows:

Section 1. The business affairs of this corporation shall be managed by the Board of Directors. The number of Directors may be increased from time to time, by the by-laws, but shall never be less than five (5).

2. **Article IX (Location)** is amended to read as follows:

Section 1. The business address of the corporation shall be 700 N.W. 21st Avenue, Pompano Beach, Florida. The Registered Agent shall be Samuel A. Price, Esquire.

Section 3. Regular meetings shall be held on the first Tuesday of each month.

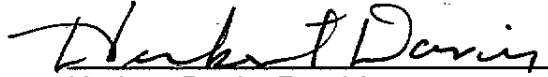
2. **Article X (Quorum)** is amended to read as follows:

3. Article XIX (Election of Board of Directors) is amended to read as

follows:

Section 1. The Board of Directors shall be elected annually by majority vote of the members in good standing present at the meeting.

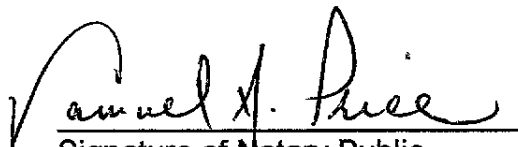
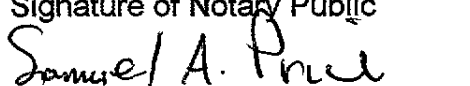

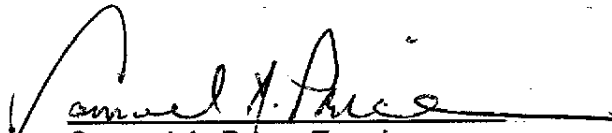
