c. When all debts, liabilities, and obligations of the Corporation have been paid and discharged, or adequate provision made therefore, and all the

remaining property and assets of the Corporation have been transferred, conveyed, or distributed in accordance with this Plan and the Act, file Articles of Dissolution and an authenticated copy of this Plan with the Florida Department of State pursuant to Sections 617.1403 and 617.1406 of the Act;

- d. Upon filing Articles of Dissolution, publish notice pursuant to Section 617.1407 of the Act and provide notice to all known creditors and claimants pursuant to Section 617.1408; and.
- e. Take such other reasonable actions, not inconsistent with this Plan, as may be necessary to effect the dissolution of the Corporation.
