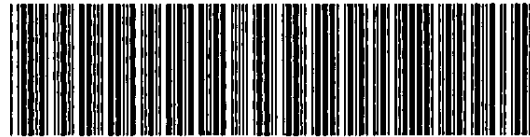

Pursuant to the provisions of Section ^{617.1000}~~617.01~~, Florida Statutes, this Florida Not for Profit Corporation adopts the following amendment to its Articles of Incorporation: Article 7 is amended to read, in the Second and Third sentences: **The number of Directors constituting the present Board of Directors is five (5). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than five (5).**

This amendment, adopted at the Member's Annual Meeting on 28 January, 2013, reduces the minimum number of Directors from nine (9) to five (5).
