THE LAKES VILLAS CONDOMINIUM II ASSOCIATION, INC.

1. ARTICLE X, Amendments, of the Articles of Incorporation shall be amended to read as follows:

Amendments to the The Articles of Incorporation may be amended by the affirmative vote of seventy-five (75%) percent of the unit owners present, in person or by proxy, and voting at a duly noticed meeting of the membership at which a quorum is present. shall be proposed and adopted in the following manner:

- 10.1 Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 10.2 A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided, such approvals must be:
 - a. by not less than 75% of the entire membership of the Board of Directors and by not less than 75% of the votes of the entire membership of the Association; or
 - b. by not less than 80% of the votes of the entire membership of the Association.
- 10.3—Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of members, nor any change in Section 4.3 of Article IV, without approval in writing by all members and the joinder of all owners of mortgages upon the condominium. No amendment shall be made that is in conflict with the Condominium Act or the Declaration of Condominium.
- 10.4—A copy of each amendment shall be certified by the Secretary of State and be recorded in the Public Records of Pinellas County, Florida.
