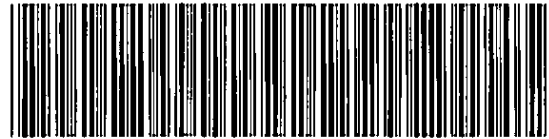

WE, the undersigned, together with other persons being desirous of forming a corporation incorporated for charitable and nonprofit purposes, under the provisions of the Florida Statutes, do agree as follows:

ARTICLE I. NAME

The name of this corporation shall be Miami Mineral And Gem Society, Inc. The principal office of this nonprofit corporation shall be Suite 446, 36 N.E. First Street, Miami, Florida, 33132, and the mailing address for the nonprofit corporation shall be Post Office Box 420241, Allapattah Station, Miami, Florida, 33142.

ARTICLE II. PURPOSES

The purposes for which this nonprofit corporation is organized are as follows:

Promotion and advancement of projects in pursuit of the betterment of the community, human relations, arts and social sciences.

Protection, preservation and maintenance of life, health, dignity and civil rights of mankind.

To award individuals and/or organizations who do something outstanding or perform noteworthy acts in giving and sustaining life and liberty. Strive to advance humanity toward higher moral considerations and more humane conduct in their behavior toward others and most especially assist morally, physically, financially and otherwise those who are oppressed.

ARTICLE VIII. BY-LAWS

ARTICLE IX. AMENDMENTS

In order to promote the purposes of this nonprofit corporation, it may acquire property by grant, gift, purchase, devise or bequest and hold or dispose of such property as the nonprofit corporation shall require for the benefit of the members and not for pecuniary profit; it may purchase, lease, hold, sell, develop, erect, build, mortgage, convey, or otherwise acquire and dispose of real and personal property and maintain and operate the same for the use and enjoyment of all the members of the nonprofit corporation subject to such rules, regulations and restrictions as set forth in the by-laws of this nonprofit corporation and as determined by the Board of Directors at regular meetings. It shall have all of the powers of corporations not for profit as provided by the Laws of the State of Florida. This corporation shall also have all of those corporate powers enumerated in Florida Statute 617.021.

ARTICLE XI. NONPROFIT STATUS

No part of the net earnings of the nonprofit corporation shall inure to the benefit of any individual or member, except that the corporation may pay compensation in a reasonable amount to its members, directors and officers for services rendered, or as provided under Florida Statute 617.011.

ARTICLE XII. PROHIBITED ACTS

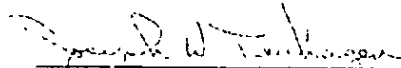
