

To Whom it May Concern:

Florida Craftsmen permanently moved their office and statewide headquarters on July 1, 1995. Our *forwarding address* was made available through July 1, 1996 -- and many times after that date, our local Post Office would still manage to find us and deliver mail with the old address attached.

Every year we would automatically receive the Annual Report and Corporation Renewal, and we would promptly update the form, pay the fee and mail it back. It was not something we naturally 'put on our calendar' in anticipation of each year, and something that could easily be forgotten about if it didn't appear as a regular bill. I am surprised that the Division of Corporations does not have mail forwarded nor do they research old addresses. Imagine our surprise when we contacted you last week and found out we needed to be reinstated.

I ask that you kindly waive the penalty fee as I feel we were innocently not at fault for failing to update this form. If you refer to our history, these forms were never late and were taken seriously. Enclosed is a check for \$183.75, which updates our records as a non-profit corporation for the years 1997, 1998 and 1999.
