

- 1. Section XI of the Articles of Incorporation shall be amended to read as follows:

"The original BY-LAWS of the ASSOCIATION shall be adopted by a majority vote of the Directors of the ASSOCIATION and thereafter, such BY-LAWS may be altered or rescinded in the same manner as these ARTICLES OF INCORPORATION as hereinafter specified as provided for in the BY-LAWS."

In order for such amendment or amendments to become effective, the same must be approved by an affirmative vote of sixty-six (66%) percent a majority of the entire membership of the BOARD and by an affirmative vote of the members having seventy-five (75%) sixty (60%) percent of the votes in the ASSOCIATION. Such amendment or amendments shall be filed within ten (10) days from said approval with the Office of the Secretary of State of Florida for approval, along with the appropriate filing fee, and thereafter recorded in the public records."
