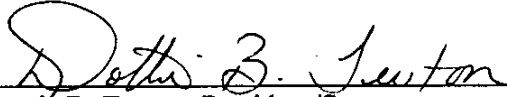

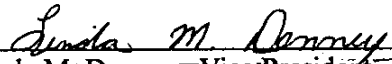

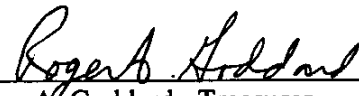
Each of the officers so elected thereupon accepted the office to which he or she was elected as aforesaid.
