## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TRINITY TOWERS SOUTH, INC.

Trinity Towers South, Inc., a Florida not-for-profit corporation, hereby submits to the Florida Secretary of State these Articles of Amendment to its Articles of Incorporation, as amended:

I. The name of the corporation is Trinity Towers South, Inc.

II. Article TENTH of the Articles of Incorporation is hereby deleted in its

entirety and replaced with the following:

## "ARTICLE -TENTH

No part of the net earnings of this corporation shall be distributed to, or inure to the benefit of any member, director or officer of this corporation, contributor or a private individual. In the event of dissolution, winding up, or other liquidation of the assets of this corporation, its assets shall be distributed to an entity which is qualified for exemption from taxes under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any successor Internal Revenue law."

III. The Amendment made to the Articles of Incorporation of the corporation

filed with the Florida Secretary of State on October 13, 1980 is hereby deleted.

IV. Article TWELFTH of the Articles of Incorporation as added by the

Articles of Amendment filed with the Florida Secretary of State on October 31, 2003 is hereby deleted.

V. These Articles of Amendment were adopted on the  $12^{\text{m}}$  day of 2013 by the members of the corporation and the number of votes cast for the amendment was sufficient for its approval.
