Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

AMENDMENTS ADOPTED

ARTICLE THIRD, PARAGRAPH B is hereby amended to read as follows: The Association shall have one class of voting membership which shall consist of all members. Each member shall be entitled to one (1) vote for each five (5) acres of property owned (i.e., any member owning 5 acres ore more of land, but less than 10 acres, shall be entitled to 1 vote; any member owning 10 acres or more of land, but less than 15 acres, shall be entitled to 2 votes, etc.); provided however, there shall be no more than one vote for each 5 acres regardless of the number of owners thereof. In the event that any 5 acre parcel is owned by more than one owner, such owners shall designate in writing, upon such form as may be provided by the Association from time to time, the party who shall be entitled to cast the vote for such parcel.

ARTICLE THIRD, PARAGRAPH F is hereby amended to read as follows: The number of members of this Association shall not exceed forty-three (43).

The date of adoption of the amendments was: November 13, 2006.
