TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 617.1006 of the Florida Not For Profit Corporation Act, CHILD ABUSE COUNCIL, INC., a Florida not for profit corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation is CHILD ABUSE COUNCIL, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on December 23, 1977, as amended by the Articles of Amendment to the Articles of Incorporation filed on June 28, 1983, and as amended by the Articles of Amendment to the Articles of Incorporation filed June 7, 2000.

ARTICLE II
AMENDMENT TO ARTICLE I

Article I of the Articles of Incorporation of this Corporation is hereby amended for the purposes of changing the name of the Corporation by deleting the existing Article I in its entirety, and substituting the following therefore to wit:
