"Article [I
Purpose
2.1 This corporation's purposes shall include any charitable, educational, religious, or scientific purposes
allowed under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and any
corresponding provisions and subsequent United States Internal Revenue Code or law. Without limiting.
the foregoing, this corporation shall have the following purposes:
(a) To provide for affordable rental housing for low income families, individual and the elderly and handicapped
and provide facilities and services specifically designed to meet the physical, social, and psychological
needs of low income, aged and handicapped and contribute to their health, security, happiness and
usefulness in longer living.
(b) To plan, construct, operate, maintain, and improve such affordable rental housing and related facilities
and services for families and individuals and the elderly and handicapped.
(c) To acquire by gift or purchase, hold, sell, convey, assign, mortgage, or lease any property, real or
personal, necessary or incident to the provision of such affordable rental housing and related services.
(d) To borrow money and to issue evidences of indebtedness in furtherance of any and all of the objects
of its business; and to secure loans by mortgage, pledge, deed to secure debt, or other lien.
(c) To apply for, obtain, and contract with any Federal Agency for a direct loan or loans or other financial
aid in the form of mortgage insurance or otherwise for the provision of such affordable rental housing and
related facilities and services.
