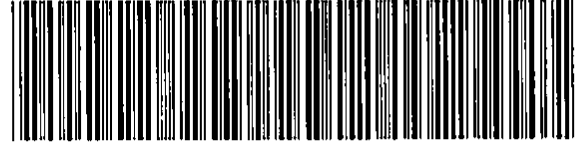

ARTICLES OF INCORPORATION
OF
YOUNG MEN'S CHRISTIAN ASSOCIATION OF MARTIN COUNTY, FLORIDA, INC.
(A Corporation Not For Profit)

We, the undersigned, hereby associate ourselves for the purpose of forming a corporation not for profit under the provisions of Chapter 517 of the Florida Statutes, and hereby adopt the following Articles of Incorporation for such purpose.

ARTICLE I

Name

The name of the corporation shall be: YOUNG MEN'S CHRISTIAN ASSOCIATION OF MARTIN COUNTY, FLORIDA, INC.

ARTICLE II

Purposes and Powers

The general nature of the object of the corporation shall be the spiritual, intellectual, social and physical education and growth of its members and constituency, consistent with the spirit and teachings of Christianity and, in cooperation with other constructive agencies, render such services in the community as will tend to better social, economical, moral and spiritual conditions for society; and to associate persons united by a common loyalty to Christian principles in a worldwide fellowship, for the purpose of developing Christian personality and building a Christian society; to acquire and hold with power to sell, mortgage, or lease such real estate as may be necessary to accomplish such purpose.

ARTICLE III

Membership Qualifications, Dues and Assessments

Any person over seventeen (17) years of age who is of good moral character and in sympathy with the purpose of this corporation as defined in Article II hereof, may become a voting member of this Association as provided in the By-Laws of the association. Admission to membership shall be by application to and approval by the Board of Directors.

Membership dues and assessments may be charged and collected, and provisions therefore may be prescribed in the By-Laws of the corporation and by such By-Laws

the Board of Directors may be empowered to determine and collect such fees, dues and assessments. Voting privileges shall be limited to active members.

ARTICLE IV

Term of Existence

This corporation shall have perpetual existence.

ARTICLE V

Location

The location of this corporation shall be at 509 Palm Beach Avenue, Stuart, Martin County, Florida.

ARTICLE VI

ARTICLE VII

Management

Section 1: The affairs of the corporation shall be managed by a Board of Directors of not less than fifteen (15) nor more than thirty-three (33) persons, no more than one of whom may be under the age of twenty-one (21), and who possess the qualifications of membership in the association as defined in this Charter. The Board of Directors shall include a President, one or more Vice Presidents, a Secretary and a Treasurer. These shall also be the officers of the corporation. They shall be chosen by and from the Board of Directors.

Section 2: The Board of Directors shall have and exercise all the powers necessary to direct the work and policy of the corporation in all its details. No contract, debt or obligations shall be binding unless entered into under authority of the Board.

Section 3: The Board of Directors shall be elected at the annual meeting of the corporation to be held in the month of February in each year and shall serve for three (3) years. The officers shall be elected at the first meeting of the Board of Directors thereafter. Vacancies shall be filled as prescribed in the By-Laws. Insofar as the number of Directors to be designated in the By-Laws is susceptible of division by three, one-third of the first Board shall serve for three years, one-third for two years, and one-third for one year.

Section 4: No question of a sectarian or partisan political character shall be acted upon or discussed in any meeting of this corporation or of its Directors.

ARTICLE VIII

Officers

ARTICLE XI

By-Laws

The By-Laws of the corporation are to be made, altered or rescinded by the Board of Directors at any regular meeting of the Board of Directors, by a two-thirds vote of all members present, provided notice of such amendment shall have been given in writing at a previous regular meeting held not less than ten (10) days prior thereto.

ARTICLE XII

Amendments to Articles of Incorporation

These Articles of Incorporation may be amended by a two-thirds vote of the

ARTICLE XV

Non-Profit Status

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate or public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law); or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

ARTICLE XVI

Distribution of Assets upon Dissolution

Upon dissolution of this corporation, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code, to the Federal Government, or to a state or local government for a public purpose and none of the assets will be distributed to any member, officer or trustee of this corporation.

ARTICLE XVII

Powers

To the end that the foregoing purpose and any other related charitable purposes and objects may be carried out, performed and accomplished, and to obtain funds or income for said charitable purposes, this corporation shall have power to:

Section 1: Acquire, either by gift, grant, purchase, devise or bequest, and to hold, own, manage, sell, grant, convey, mortgage, pledge or otherwise encumber, lease, improve and dispose of real, personal or mixed property wheresoever situated; to operate said properties, or any part thereof, or any business it may acquire in any location, in the name of the corporation or in any other manner, and for its benefit and in its behalf, through such persons or agent as it may determine or select from time to time by a majority action of the directors; to receive donations, gifts, and endowments, and to administer the same; all such real, personal and mixed property so acquired or received by gift, grant, purchase, devise, bequest or donation shall be used and employed, however, for educational, religious, charitable, social and benevolent purposes and not for pecuniary profit of the members.

Section 2: Formulate and adopt By-Laws and to alter and rescind the same, provided, however, that said By-Laws shall be agreeable to, within and not beyond or contrary to the powers herein granted, or to any laws of the United States or to the State of Florida.

Section 3: And in general, to possess and exercise all the rights, privileges, immunities and prerequisites now or hereafter authorized by or under the provisions of the Laws of the State of Florida.

ARTICLE XVIII

Meetings

Section 1: The annual meeting of the election of members of the Board of Directors shall be held as may be provided in the By-Laws.

Section 2: The corporation may provide in its By-Laws for the holding of additional regular meetings and any special meetings, and shall provide notice of all such meetings.

Section 3: The percentage of the members necessary to constitute a quorum for the holding of any meetings shall be determined in the By-Laws.

ARTICLE XIX

Designation of Registered Agent

JOHN A. DARLSON, Esquire, 955 South Federal Highway, P.O. Box 1918, Stuart, Florida 33494, shall be the Registered Agent for the corporation. He has so consented to said appointment below.
