ARTICLE XI AMENDMENTS

(Section 1 Unchanged)

2. After the Declaration is recorded tThese Articles may be amended in the following manner:

(Subsection A Unchanged)

B. A resolution seeking the approval of a proposed amendment may be proposed by either the Board of Directors or the Membership, and, after being proposed and approved by one of said bodies, it must be submitted for approval and thereupon receive approval of the other. Such approval must be by seventy-five percent (75%) two-thirds (2/3) of the members present (in person or by proxy) and voting at any meeting at which there is a quorum; and such approval must be by sixty-six and two thirds percent (66 2/3%) of the members of the Board at a meeting at which there is a quorum.
