

CORRECTED CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR BEACHTREE I CLUSTER, INCORPORATED

(This documents corrects scrivenor's errors in that certain Certificate of Amendment to the Articles of Incorporation for Beachtree I Cluster, Incorporated, File #4897507, recorded in Official Records Book 4652, Page 507-508, on July 21, 2021, public records of St. Lucie County, Florida.)

The Articles of Incorporation for Beachtree I Cluster, Incorporated were recorded in the public records of St. Lucie County, Florida at Official Records Book 296, Page 1499 and amended at Official Records Book 3382, Page 790. The Articles of Incorporation are hereby amended as approved by the membership.

1. Article IX is amended to read as follows:

ARTICLE IX

BY-LAWS

The By-Laws of the Corporation shall be adopted by the Board of Directors. The By-Laws may be amended, altered, or rescinded at a duly constituted membership meeting for such purpose, provided, however, no amendment shall take effect unless approved by members representing at least fifty percent (50%) plus one (1) of the total votes cast in the Condominium-Voting-in person or by proxy at the meeting. In addition, said amendment shall conform to the requirements of Article VII of the Declaration of Condominium.

- 2. The foregoing Amendments to the Articles of Incorporation for Beachtree I Cluster, Incorporated were adopted by the membership by approval of at least fifty percent (50%) plus one (1) of the members.
- 3. All provisions of the Articles of Incorporation for Beachtree I Cluster, Incorporated are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
