Articles of Amendment Articles of Inicorporation

Whereas, the ministry is committed to preserve Scriptural morals in the face of outside societal influences seeking to degrade the Biblical family, pervert the moral values of our nation, and intimidate God's people from speaking God's truth in love, the following paragraphs shall be added to the ministry's Statement of Faith:

(Article 15) Sexual Immorality

- 1. We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man and a woman. We believe that any form of homosexuality, lesbianism, bisexuality, bestiality, incest, fornication, adultery, and pornography are sinful perversions of God's gift of sex. We believe that God disapproves of and forbids any attempt to alter one's gender by surgery or appearance. (Gen. 2:24; Gen. 19:5, 13;Gen. 26:8-9; Lev.18:1-30; Rom. 1:26-29;1 Cor. 5:1; 6:9; 1 Thess. 4:1-8; Heb. 13:4)
- 2. We believe that the only Scriptural marriage is the joining of one man and one woman. (Gen. 2:24; Rom. 7:2; 1 Cor. 7:10; Eph. 5:22-23)

(Article 16) Lawsuits Between Believers.

We believe that Christians are prohibited from bringing civil lawsuits against other Christians or the church to resolve personal disputes. We believe the church possesses all the resources necessary to resolve personal disputes between members. We do believe, however, that a Christian may seek compensation for injuries from another Christian's insurance company as long as the claim is pursued without malice or slander. (1 Cor.6:1-8; Eph. 4:31-32).

Membership

Whereas, membership in this body is a privilege and not a right and carries with it specific responsibilities and moral obligations, the following provision shall be added to Membership:

The membership of any individual member shall automatically terminate without notice if the member states that he or she is actively involved in any conduct described in article 15 or files a lawsuit in violation of article 16.

On the 5^{th} day of January, 2015, the members of New Light Church Inc. approved this amendment with a 29 to 0 vote, a sweeping majority in favor of Articles 15 and 16.
