Pursuant to the provisions of Section 617.100 6. Florida Statutes, this Florida Not For Profit Corporation adopts the following Amendments to its Articles of Incorporation, Article II. Article III and Article IV, only:

ARTICLE II.

PURPOSE. The purpose of this organization (hereinafter referred to as "Club") shall be to stimulate interest in and appreciation for the art of decorative painting through group meetings. education, communication and exhibition. This Club is organized exclusively to educate and preserve the art of decorative painting, the history of tole and decorative painting, and for non-profit and charitable purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE III.

MEMBERSHIP AND DUES. Membership in this Club shall be open to persons who, in accepting membership, thereby agree to be bound in all things not contrary to the Club's Bylaws. An active member may withdraw from the Club by giving notice to the Membership Chair. All Club obligations must be fulfilled and any property of the Club must be returned on or before the withdrawal date. Membership dues shall be paid annually on a calendar-year basis. Due dates and the amount of dues shall be stated in the Club's Standing Rules. All dues collected must be used for the purpose of the Club and shall not be used for the benefit of any individual member or members. officers, directors or board members.

ARTICLE IV.

CLUB DISSOLUTION. Upon final dissolution of the Club and surrender of the Club's name, and after all Club's debts are fully paid, a distribution shall be made of the remaining funds and/or property of the Club to a charitable non-profit organization as directed by the last Board or the remaining members. These remaining funds and/or property of the Club shall be distributed for one or more exempt purposes within the meaning of Section 501(e)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

The date of each amendment(s) adoption shall be July 1, 2022, if other than the date this document is signed.

Effective date <u>if applicable</u>: January 1, 2023 (no more than 90 days after amendment file date). Note: If the date inserted above does not meet the applicable statutory filing requirements, this date will not be listed as the document's effective date on the Department of State's records.
