THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CAPRI "L" ASSOCIATION, INC. are made by the CAPRI "L" ASSOCIATION, INC. ("Association").

## WITNESSETH:

WHEREAS, the Articles of Incorporation of the Association were originally filed with the Florida Secretary of State on February 16, 1978 (Document Number 742040).

NOW, THEREFORE, the President and Secretary of the Association hereby certify that:

The Amendment to the Articles of Incorporation set forth below has been properly and duly approved and adopted on April 11, 2021. The number of votes cast in favor of the Amendment is sufficient for approval. Further, the Amendment set forth below has been properly and duly approved by the Board of Directors. The Association has properly approved and adopted the Amendment set forth below pursuant to the provisions of the Articles of Incorporation.

Section 9.1 of the Articles of Incorporation shall be amended to read as follows:

"9.1 Number and qualification. The property, business and affairs of the Association shall be managed by a board (commencing with the December 2022 annual meeting) consisting of five (5) directors the number of directors determined by the By-Laws, but which shall consist of not less than three (3) directors, and which in the absence of determination otherwise, and for so long as the Developer is entitled to representation on the board, shall consist of three (3) directors. Except for directors appointed by the Developer. All directors must be either members of the Association or residents of a unit in the Condominium.
