CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF HARBOUR SIDE CONDOMINIUM ASSOCIATION OF VERO BEACH, INC.

The Articles of Incorporation of Harbour Side Condominium Association of Vero Beach, Inc. were filed with the Florida Secretary of State on April 6, 1978. The same Articles of Incorporation were recorded in Official Records of Indian River County, Florida at Official Records Book 593, Page 1439, et seq., Official Records Book 603, Page 2872, et seq., Official Records Book 626, Page 2527, et seq. and amended at Official Records Book 615, Page 1681, et seq. and Amended and Restated at Official Records Book 1215, Page 224, et seq. Harbour Side Condominium Association of Vero Beach, Inc., by its duly authorized officers, hereby certifies that the amendments to these Articles were approved by at least 2/3 of the total votes of the members, which vote was sufficient for approval at their Special Members Meeting held on May 21, 2020.

- 1. Article VIII is amended to read as follows:
- 8.1 Notice of the subject matter of a proposed amendment will be included in the notice of any meeting at which a proposed amendment is to be considered.
- 8.2 An amendment to these Articles may be proposed either by the Board of Administration or by at least ten percent (10%) of the voting interests of the Association. Except as elsewhere provided, such approvals must be by:
- (a) not less than a majority of the entire membership of the Board of Administration, and
- (b) not less than seventy-five percent (75%) of those Members of the Association, voting in person or by proxy at a meeting at which a quorum is established, or by at least seventy-five percent (75%) of those Members of the Association voting by written consent, as long as at least a quorum of Members vote.

(The balance of Article VIII remains unchanged)

2. The foregoing amendment to the Articles of Incorporation of Harbour Side Condominium Association of Vero Beach, Inc. were approved by at least 2/3 of the total votes of the members, which vote was sufficient for approval at their Special Members Meeting held on May 21, 2020.
