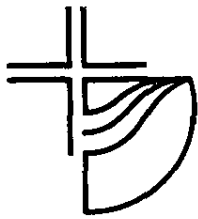

To Whom It May Concern:



As far as I can tell:

Our Church had a P.O. Box and recorded it as our Annual Report mailing address. At some point after our new board was installed in 98/99 and during our budget review, it was thought that a P.O. Box was an unnecessary expense and it was canceled. This resulted in the information packet for our next Annual Report filing to be returned to Tallahassee as undeliverable mail.
