AMENDMENT TO ARTICLES OF INCORPORATION FOR DOLPHIN WAY OF HICKORY POINT CONDOMINIUM ASSOCIATION, INC.

WHEREAS, in compliance with the requirements of Chapter 617, Florida Statutes, Dolphin Way of Hickory Point Condominium Association, Inc. ("Association"), a Florida not-for-profit corporation, filed its Articles of Incorporation with the Florida Secretary of State on April 25, 1978; and subsequent amendments thereto ("articles of Incorporation:).

WHEREAS, the Association wishes to amend its Articles of Incorporation in accordance with the terms and conditions set forth below and pursuant to Article IX therein.

NOW, THEREFORE, the Articles of Incorporation are hereby amended as follows [all deleted text is overstricken and all added text is in bold and italics]:

1. Article VI, is amended to read as follows:

The affairs of the corporation are to be managed by the Chairman President, Vice Chairman -President, Secretary, and Treasurer and such other officers as the Board may from time to time create by resolution. of the corporation and Such officers shall be elected appointed by the members of the Association-annually Board of Governors at the first meeting of the Board following each annual meeting of the Owners.
