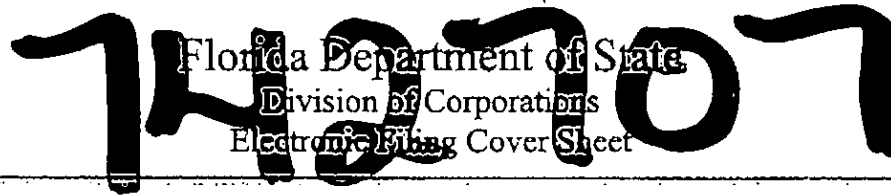

**ARTICLES OF DISSOLUTION

PANHANDLE TIGER BAY CLUB, INC., a Florida corporation not for profit under the provisions of Chapter 617, *Florida Statutes* (the "Corporation"), hereby files these Articles of Dissolution evidencing the Corporation's dissolution and discontinuation of business, and sets forth the following pursuant to the provisions of Section 617.1403, *Florida Statutes*:

1. The name of the corporation is PANHANDLE TIGER BAY CLUB, INC.
2. The Corporation was formed effective on May 5, 1978, and was assigned document number 742707, and federal tax identification number 59-2496417.
3. The Corporation has members with voting rights.
4. Upon recommendation of the Board of Directors of the Corporation, the Members adopted resolutions to dissolve the Corporation.
5. The date of the meeting of the Members at which the resolutions to dissolve were adopted was November 15, 2019. The number of votes cast by the Members at such meeting was sufficient for approval.
6. The Dissolution of the Corporation is effective upon the filing of these Articles of Dissolution with the Florida Department of State.
