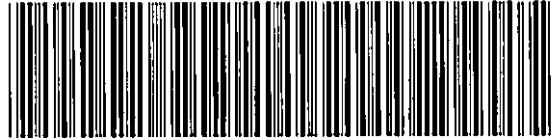

We, the undersigned, with other persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provisions of Chapter 817 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of this corporation is FRANK B. HUDDLESTON POST NO. 81, INC.

ARTICLE II PURPOSES

The general nature of the objects and purposes of this corporation shall be to promote and advance the principle and social interest of FRANK B. HUDDLESTON POST NO. 81, INC. and the national and department constitutions, and to provide recreational and social entertainment for members of the American Legion, their guest and friends.

ARTICLE III QUALIFICATION OF MEMBERS

ARTICLE IX DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law to the Federal state or local government for exclusive public purpose.

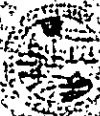
