We are filing for Reincorporation of Round Lake Park Homeowners Association, Inc. Over the past eight years all of our addresses have changed at least three times. As nearly as we can determine, we were RR 7 with individual box numbers at the time of Incorporation Status in 1978. In 1998 we were changed to RR 4, but our box numbers remained the same. In 1999 or 2000 we were changed to 9-1-1 addresses. Several of us had problems receiving our mail. Some of us even received overdue notices because the notices were not received. Our notice of Corporation Renewal was apparently in this group, in addition to the fact that we had changed officers. We now know that our status became inactive on 24 September 1999. Your records show an address and officer change on 04 April 1996, but we were still RR 7 when my family moved to Round Lake Park in 1997. Individual family Association Dues are paid annually.
