## PLAN OF LIQUIDATION AND DISTRIBUTION OF ASSETS OF WINTER PARK SUNRISE KIWANIS CLUB, INC.

### Authorization for Dissolution

1. On January 6, 2000, the Board of Directors of the Corporation adopted and approved a resolution that the Corporation be dissolved, the members not being entitled to vote. The date of Board adoption and approval of the plan is hereafter referred to as the "effective date."

2. The Board of Directors of the Corporation has determined that it is in the best interests of the Corporation and of its members that the liquidation of the Corporation and the distribution of its assets be made pursuant to a formal, written plan of liquidation and distribution.

3. After the effective date, the Board of Directors and the Officers of the Corporation shall sell all of the assets of the Corporation. Any sales shall be made on the terms and conditions and for the consideration that the Board deems reasonable and in the best interests of the Corporation and its members. The Board of Directors may execute any instruments that are necessary to transfer title to the property and assets.

4 Prior to making any distribution of corporate assets, the Board of Directors and the officers shall pay all of the known or ascertainable debts of the Corporation.

5. After payment of all of the known or ascertainable debts and liabilities of the Corporation, the Board of Directors and Officers of the Corporation shall distribute the remaining assets of the Corporation to the Kiwanis Club of Casselberry Winter Park, Inc., a Florida Not For Profit corporation.

6. The Board of Directors and officers of the Corporation shall carry out the provisions of this plan and shall take all actions necessary or advisable to effect the complete liquidation of the Corporation and its dissolution, including the execution of such instruments as may be required to transfer title, and the execution of all documents required by law to be filed to effect the dissolution of the Corporation.
