

ARTICLES OF AMENDMENT TO AMENDED ARTICLES OF INCORPORATION OF SHOREHOM BY THE SEA. INC.

Pursuant to the provisions of §617.1006, Fla. Stat., SHOREHOM BY THE SEA. 18C. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation TALL ARASSEF, FI

FIRST: Amendment adopted:

Article XII, Section 3.2.g. of the Amended Articles of Incorporation of Shorehom by the Sea, Inc. ("Articles of Incorporation") is hereby amended as follows (additions are indicated by <u>underlining</u>; deletions are indicated by <u>strike outs</u>, omitted and unaltered provisions are indicated by ellipses):

[...]

ARTICLE III Powers

The powers of the Association shall include and be governed by the following provisions:

3.2 The Association shall have all of the powers and duties set forth in the Condominium Act, except as limited by these Articles and the Declaration of Condominium, and all of the powers and duties reasonably necessary to operate the condominium pursuant to the Declaration as presently drafted and as it may be amended from time to time, including but not limited to the following:

[...]

g. [Subsection g. intentionally left blank.] To approve or disapprove the leasing, transfer, mortgage and ownership of units as provided by the Declaration of Condominium and the By-Laws of the Association.

[...]

THIRD: Adoption of Amendment:

Article IX, Section 9.2 of the Articles of Incorporation, in effect prior to the adoption of the instant Amendment, provides that amendments to the Articles of Incorporation shall be approved by not less than 75% of the entire membership of the Board of Directors and not less than 75% of the votes of the entire membership of the Association.

The Board of Directors of the Association and members of the corporation were entitled to vote on the Amendment. The Board of Directors and members of the Association duly adopted

this Amendment in accordance with the above-stated provision. The number of votes cast for the Amendment was sufficient for approval.
