ARTICLE VII - MEMBERSHIP

1. Types of Members: The membership shall consist of the following types: ~~---Active, Life, and Honorary and Associate~~ Mmembers.

a. Active Members: Any person of Scottish birth, or descent, or who has a sincere interest in Scottish history and traditions, and who is at least eighteen (18) years of age shall be eligible for membership.

b. ~~Associate-Members:---Any other person shall be eligible for Associate-Membership who has a sincere interest in Scottish customs and traditions.---Application procedures for admission and annual dues shall be the same as for Active-Members. No person shall be excluded from Associate-Membership by reason of sex, race, creed, national origin or any illegal purpose.~~

e. Life Members: Any member, upon payment of dues twenty (20) years in advance, shall be eligible for Life Membership.

hc. Honorary Members: Any person shall be eligible for Honorary Membership ~~or Honorary Life-Membership~~ upon recommendation ~~of~~ by the Board of Trustees and approval by ~~two-thirds (2/3)~~ three-fourths (3/4) of the votes cast at a general business meeting of the Society.
