Pursuant to the provisions of F.S. §617.1006, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** Article X, BOARD OF DIRECTORS, page 5, paragraph 1, first sentence only, is amended as follows. Remainder of the paragraph remains unchanged.

1. The number of members of the Board of Directors shall be as set forth in the bylaws three (3).

(remainder of paragraph remains unchanged)

**SECOND:** Article XIII, AMENDMENTS, page 6, paragraph 2, is amended as follows.


2. ~~A resolution approving a proposed amendment may be proposed by either the Board or by the membership of the Association, and after being proposed and approved by one of said bodies, it must be submitted for approval and thereupon receive such approval of the other. Such approval must be by seventy-five percent (75%) of the members of the Association, and such approval must be by two-thirds (2/3) of the members of the Board. These articles may be amended by a majority vote of the entire number of votes in the Association.~~

**THIRD:** The date of the adoption of the amendments was September 10, 2002.

**FOURTH:** The amendment was adopted by the members and the board of directors, and the number of votes cast for the amendment was sufficient for approval.
