I have also enclosed a check in the amount of \$43.75 to cover the cost of the name change and a certified copy of the amendment.

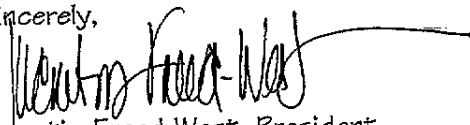
