

BY THESE ARTICLES OF INCORPORATION the subscribers form a corporation not for profit under Florida law.

- 1. NAME. The name of the corporation is SPINDRIFT CONDOMINIUM ASSOCIATION, INC.
- 2. <u>PURPOSE</u>. The corporation is organized to administer a condominium known as SPINDRIFT CONDOMINIUM in Sarasota County, Florida. The corporation shall issue no stock and make no distribution of income to its members or directors.
- 3. <u>MEMBERS</u>. (a) The members of the corporation shall be the owners of record of units in the condominium or, after it is terminated, the owners of record at the time of termination.
- (b) After receiving approval as required by the declaration of condominium, change of membership in the corporation shall be accomplished by recording an instrument in the public records of Sarasota County, Florida, conveying title to a unit in the condominium.
