## Statement of Facts

We, the undersigned officers of The Church at Deerfield Beach, Inc. hereby reaffirm the following:

### 1. Continued Fraudulent Filings and Harassment

Despite the **Statement of Facts** filed on **December 13, 2024**, on the Florida SunBiz website, which detailed multiple fraudulent filings by **Jack Lowther and Tom Lund**, these individuals have continued their unlawful actions. They persist in submitting unauthorized corporate documents in an effort to misrepresent their affiliation with the church and undermine its legitimate leadership.

### 2. Reference to Prior Statement of Facts

For examples of prior fraudulent filings and the church's official response, we refer all relevant parties to the **Statement of Facts** filed on **December 13, 2024**. This document remains in effect and outlines many of the fraudulent actions taken by **Jack Lowther and Tom Lund**, as well as the church's position on their lack of authority.

### 3. Ongoing Harassment and Unauthorized Filings

- **Jack Lowther and Tom Lund** ceased all affiliation with The Church at Deerfield Beach in **2022** (Mr. Lowther in **November 2022**, and Mr. Lund in **August 2022**). Despite this, they continue to falsely represent themselves as having authority within the church.
- Since the filing of the **December 13, 2024, Statement of Facts**, these former members have **persisted in filing fraudulent corporate documents**, falsely amending records, and attempting to mislead the public regarding the true leadership of the church.
- **The Church at Deerfield Beach** is a self-governing, congregational church, independent of any larger religious hierarchy. True leadership within our church requires active participation in the local congregation and regular attendance at weekly services. **Jack Lowther has not attended any official church services since October 2022 and has since sold his house and moved approximately three hours away**, no longer residing in the local area, yet he continues his campaign of harassment from a distance, further demonstrating his intent to interfere with the legitimate operations of The Church at Deerfield Beach.

### 4. Lack of Authorization

- **Jack Lowther and Tom Lund** are not officers, elders, or members of The Church at Deerfield Beach, Inc.
- They have no authority to file documents, make amendments, or take any action on behalf of the church or its corporation.

- Any and all **future filings** made by these individuals should be considered **fraudulent and invalid**.

## 5. Public Notice and Request for Action

We urge all relevant authorities and members of the public to recognize that any corporate documents submitted by Jack Lowther and/or Tom Lund **after October 26, 2022**, are fraudulent.

To verify the correct and official filings of The Church at Deerfield Beach, Inc., please refer to the documents submitted by the **duly authorized officers of the church** for example, January 03, 2025 (filing # 0560433052CC), January 17, 2025 (filing # 5338901360CC) and February 07, 2025 (filing # 4184643965CC) just to name a few. Also, please refer to the **December 13, 2024, Statement of Facts**.
