

### ARTICLES OF INCORPORATION

## ARTICLE 9

### DIRECTORS

9.1 <u>Number and qualification</u>. The property, business and affairs of the Association shall be managed by a board consisting initially of the three persons named herein and thereafter by seven (7) directors, <u>but which shall consist of not less than three (3)</u>. All directors must be either members of the Association or <u>the owners or residents of a unit or lot in the Condominium as shown on the condominium plat map of Citrus Ridge Village Condominium as recorded in Condominium Plat Book 4, Pages 135 and 136, Public Records of Orange County, Florida.</u>
