CERTIFICATE OF AMENDMENT TO THE

AMENDED AND RESTATED ARTICLES OF INCORPORATION

MARINER SANDS COUNTRY CLUB. INC

The Amended and Restated Articles of Incorporation of Mariner Sands Country Club, Inc. were filed with the Secretary of State on December 20, 2004 and the first amendment was filed on July 28, 2008. The same Amended and Restated Articles of Incorporation are hereby amended as approved by a vote sufficient for approval by its Members at a meeting held on February 28, 2011.

1. Article 7, is hereby amended as follows:

ARTICLE 7 – BOARD OF GOVERNORS

The business and affairs of the Association shall be managed by a Board of Governors consisting of nine (9) Governors who shall be elected, as provided in the By-Laws. Only Members of the Association shall be qualified to be members of the Board of Governors and six (6) members shall be Golf Members and three (3) shall be Non-Golf Members.

- 3. All provisions of the Amended and Restated Articles of Incorporation are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
