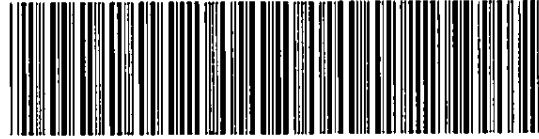

In accordance with the Articles of Incorporation of Iglesia Bautista Cristianos Unidos Inc, also known as United Cristian Baptist Church, Inc.

Removal Request.

Ismael Olvera, present Registered Agent, Melinda Olvera (CFO) Present TRS Rebeca Garcia-Sotelo (TRS), Adam S Olvera, (D) Diana Garcia (S) Virginia Saldivar Olvera. Ismael Olvera, present Registered Agent was not authorized to make any changes on May 26, 2024, April 28, 2023, July 17, 2024, September 24, 2024, and Jan. 25, 2025. The "Registered Church Members" did not have a business meeting nor were informed of the "Statements of Fact" entered by Ismael Olvera, all "Fact." Jan. 25, 2025.

The "Registered Church Members" in a business meeting, via Online, did in fact create a "Litigation Committee. Receiving assistance, and paid consultation from two Attorneys. One to assist to resolve the issue in house. The first was to help in attribution. The second being the present attorney, mentioned by Ismael Olvera in the "Statement of Fact." The goal now is to the present, issue at hand, faced by the "Registered Church Members".

The present self-appointed leaders were not appointed by the "Registered Church Members". Ismael Olvera and Melinda Olvera, his wife, Adam S. Olvera and Virginia Saldivar Olvera, their son and daughter in-law, Diana Garcia and Rebeca Garcia-Sotelo daughters to the late Lydia Garcia and Sister of Ismael Olvera, were not appointed by the "Registered Church Members.", they entered and appointed themselves.

Now, due to the present and unsafe conditions.

The changes have been made by "Registered Church Members" congregated online. After consulting with attorneys. An emergency meeting took place pursuant to 617.0701 of the Florida Statutes, and applicable state and federal law. Which "Majority Vote" changed leadership and a new committee was in fact created by present "Registered Church Members". Decisions were made, after two attempts to resolve the issue in-house.

These attempts were rejected by the self-appointed present registered leaders, who violated not only the By-Laws but by making false statements to sunbiz. Especially, by making false statements on the Statement of Facts and entering false information on June 17, 2024 entering the late Lydia Garcia as Director. When she passed away on April 13, 2024

Iglesia Bautista Cristianos Unidos, Inc. "Registered Church Members", who began congregating since 1974, now Registered with the state of Florida as , Iglesia Bautista Cristianos Unidos, Inc. also known as United Christian Baptist Church, Inc. made official with the state on April 26, 1978, request that the original Articles Of Incorporation and Constitution and By-laws of the Iglesia Cristianos Unidos, remain as originally recorded.

Article III-, page 2 "Purpose and Objectives",

The purpose and objectives of this corporation shall be to conduct the business affairs, handle legal matters, hold title, to real property and to otherwise proceed in accordance with the will, desire and directives as expressed, determined and approved by the "Members of the Fellowship" and as provided for in the By-Laws of the Church and /or corporation.

Constitutional and By-Laws of the Iglesia Cristianos Unidos: Page 1.

Requirements to become a member: The Membership of this organization will be constituted by members of the body of Christ that has a good relationship with the church and that has been registered by the organization.

Board of Directors: The Board of Directors for the organization shall be comprised of elected and appointed officials of the membership.

Constitutional and By-Laws of the Iglesia Cristianos Unidos: Page 2

The objectives of the church shall be :

1. To present the teaching of Christ in accordance with the holy scriptures, from the pulpit, from the home, through radio, television or through any other medium.
5. To sustain any cause that is considered a good cause by the members , be it in church or another person. All the things that are sustained bby the church should first be approved by the members.

1. The Board of Directors will be composed of officials elected by the church



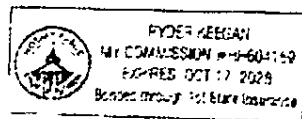
