

ADOPTED AMENDMENTS TO THE ARTICLES OF INCORPORATION OF 51 ISLAND WAY CONDOMINIUM ASSOCIATION, INC.

Adopted amendment to ARTICLE XII, Section 12.2 of the Articles of Incorporation of 51 Island Way Condominium Association, Inc., to read as follows:

ARTICLE XII: AMENDMENTS

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

12.2 A resolution for the adoption of a proposed amendment may be proposed by the Board of Directors of the Association or by the members of the Association Except as elsewhere provided, approvals of such amendments must be either by:

(a) Nnot less than seventy-five (75%) percent of the entire membership of the Board of Directors and by not less than seventy-five (75%) sixty-five (65%) percent of the votes of the entire membership of the Association; or

(b) Not less than eighty (80%) percent of the votes of the entire membership of the Association. Provided, however, that until such time as a majority of the members of the Board of Directors of the Association shall be elected by unit owners other than Developer, all amendments to the Articles of Incorporation shall be approved as set forth in paragraph 12.2(a) above.
