

ARTICLE 9 - AMENDMENTS, section 9.2, Adoption, of the Articles of Incorporation, shall be amended to read as follows:

- 9.2 Adoption. The Articles of Incorporation may be amended by an affirmative vote of not less than fifty-one percent (51%) of the entire membership of the Association. A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing the approval is delivered to the secretary at or prior to the meeting. The approvals must be either
- (a) by not less than 75% of the entire membership of the board of directors and by not less than 75% of the votes of the entire membership of the Association; or
- (b) by not less than 80% of the votes of the entire membership of the Association.
