Attachment to Articles of Amendment to Articles of Incorporation Form

Article VII, Officers, is amended as follows:

#### **Article VII - Officers**

The corporation shall have a President, Vice President, <u>a Secretary</u>, <u>and a Treasurer</u> and a Secretary Treasurer; there shall be such additional vice-presidencies and assistant officerships as the Board of Directors shall, in its discretion, determine. The offices of President and Secretary may not be filled by the same individual; otherwise, individuals may hold dual offices. The President, Vice President, <u>Secretary and Treasurer</u> and <u>Secretary-Treasurer</u> shall manage the affairs of the corporation.

Note: Double underlined text represents additions and strike-through text represents deletions. All remaining portions of Article VII remain unchanged.

Article XIII, Dissolution, is amended as follows:

#### **Article XIII - Dissolution**

Upon dissolution of this corporation, all of its assets remaining after payment of its debts and obligations and the costs and expenses of such dissolution shall be distributed exclusively for public purposes to Florida county governments, which are members in good standing of this corporation on the date of distribution, proportional to the amount of each county's annual dues and applicable special assessments.
