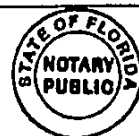

AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

SUNDIAL EAST CONDOMINIUM ASSOCIATION, INC.

(A NON-PROFIT FLORIDA CORPORATION)

ARTICLE I.

The name of this corporation is SUNDIAL EAST CONDOMINIUM ASSOCIATION, INC.

ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of Sundial of Sanibel Phases IV-VI Condominium, located at Sanibel, Lee County, Florida.

ARTICLE III.

The qualification of members and the manner of their admission shall be as follows: Any person or persons who own a condominium unit in The Condominium shall by virtue of such ownership be a member of this corporation. Such membership shall automatically terminate when such person is no longer the owner of a condominium unit.

ARTICLE IV.

This corporation shall exist perpetually.

ARTICLE IX.

The By-Laws of the corporation are to be made, altered or rescinded by the members of the corporation as provided for in the By-Laws.

ARTICLE X.

An Amendment may be proposed by either the Board of Directors or by any owner and may be considered at any meeting of the owners, regular or special, of which due notice has been given according to the By-Laws, which includes a notice of the substance of the proposed amendment. The Amendment must be approved by a vote of a majority of the members of the corporation.

ARTICLE XI.

Each unit in the condominium shall have one (1) full vote, which vote shall be cast by a designated owner as provided for in the By-Laws.

ARTICLE XII.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation by a majority vote of the members.

ARTICLE XIII.

No part of the net earnings of this corporation shall inure to the benefit of any member or individual, except through the acquisition, construction, management, maintenance, or care of association property or through the rebate of the excess membership dues, fees, or assessments.




