TALLARAM PARTIES OF STATE OF ST Pursuant to the provisions of Sections 617.1001 and 617.1002, Florida Statute TRAVELERS' REST VOLUNTEER FIRE DEPARTMENT, INC. (the "Corporation") hereby adopts the following Amendments to its Articles of Incorporation:

(NAME) The name of the Corporation is changed to TRAVELERS' Amendment I: REST VOLUNTEER FIRE AND RESCUE, INC., by which name the Corporation shall hereafter be known.

The organization is organized (CHARITABLE PURPOSES) Amendment II: exclusively for charitable, religious, educational, and/or scientific purposes under section 501 (c) (3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments an distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

All of the remaining ARTICLES, terms and provisions of the Articles of Incorporation shall remain in full force and effect.

The foregoing Amendments were adopted at a regular meeting of the members of the Corporation on March 21, 2000.


