ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF MIRROR LAKES HOMEOWNERS ASSOCIATION, INC.

THESE ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF MIRROR LAKES HOMEOWNERS ASSOCIATION, INC. is made by the MIRROR LAKES HOMEOWNERS ASSOCIATION, INC. ("Association").

WITNESSETH:

WHEREAS, the Articles of Incorporation of the Association were originally filed with the Florida Secretary of State on October 25, 1978 (Document Number 744710).

NOW, THEREFORE, the President and Secretary of the Association hereby certify that:

The Amendment to the Amended and Restated Articles of Incorporation set forth below has been properly and duly approved and adopted by the Association Members at a Special Members Meeting conducted on January 10, 2022. The number of votes cast in favor of the Amendment is sufficient for approval. Further, the Amendment has been properly and duly approved by the Board of Directors. The Association has properly approved and adopted the following Amendment.

Article V. Section 1 of the Amended and Restated Articles of Incorporation shall be amended to read as follows:

"1. The affairs of the Association will be managed by a Board consisting of the number of Directors determined by the By-Laws, but not less than five(5) three (3) nor more than seven (7) Directors, and in the absence of such determination shall consist of three (3) Directors. Directors shall serve staggered 2-year terms, with the transition accomplished as set forth in the Bylaws. Directors shall be members of the Association. In the event a Director transfers title to his Lot, he or she shall automatically be removed from the Board upon the closing of title to the Lot."
