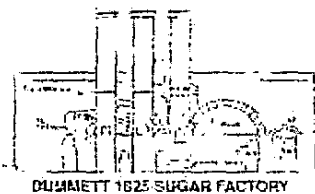

This makes the second year in a row that we have not gotten our renewal notice from your office. It appears that we have not been getting correspondence because you have an incorrect address in your records. Specifically, according to my conversation with Barbara this week, you have our zip code incorrect. Our zip is 32175 not 32174. This was the address given on the 2002-reinstatement form, as well as, in our letter to you dated June 13, 2002 (copy included). My understanding is that your office sent a communication after the June 13 date requesting a third director in order for VAS to stay in good standing. We never got the communication.
