1. To amend Article VIII of the Articles of Incorporation to read as follows:

ARTICLE VIII  
By-Laws

The first By-Laws of the Association shall be adopted by the Board of Directors and may be altered, amended or rescinded ~~by a vote of 75% of the members as provided in the By-Laws.~~

2. To amend Article IX, Section 9.2, of the Articles of Incorporation to read as follows:

ARTICLE IX  
Amendments

\* \* \*

~~9.2 A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided;~~

~~a. Such approvals must be by not less than 75% of the entire membership of the Board of Directors and by not less than 75% of the votes of the entire membership of the Association; or~~

~~b. By not less than 80% the votes of the entire membership of the Association.~~

9.2 These Articles may be amended by an affirmative vote of two-thirds (2/3) of the unit owners present and voting, in person or by proxy, at any regular or special meeting of the membership duly called and noticed in accordance with the provisions of the By-Laws, and at which a quorum is present. The notice shall contain the text of the proposed amendment or amendments, in the format required by Chapter 718 of the Florida Statutes, as amended from time to time.
