

THE UNDERSIGNED, Alex Hull, President of THE CENTRAL FLORIDA CHURCH, INC., a Florida not-for-profit corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is THE CENTRAL FLORIDA CHURCH, INC.

ARTICLE SECOND: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Articles of Incorporation is amended to provide as follows:


ARTICLE I - NAME

The name of the corporation shall be ORLANDO CHURCH OF CHRIST, INC.
