Chapter 496, Florida Statutes, requires organizations soliciting in the State of Florida to register with the Department of Agriculture and Consumer Services ("Department"). A review of the Department database reflects that your organization was previously registered to solicit contributions and failed to renew that registration. Additionally, a review of the Division of Corporations database reflects that your organization is still an active entity in the State.

Unless a provision of the Solicitation of Contributions Act ("Act") renders the statute inapplicable, registration is necessary for organizations to solicit contributions. If your organization is still soliciting contributions, it should register with the Department. The Act provides for the assessment of late registration fees in the amount of \$25 per month. The Department is offering a settlement of \$100 in late fees in addition to the registration fee if this office receives the registration application within 30 days of the date of this letter. Please note that if the provisions of the Act apply and a registration application is not received, the Department will seek its available legal remedies. Failure to comply may subject the organization to a cease and desist order and fines up to \$1000 per violation.
