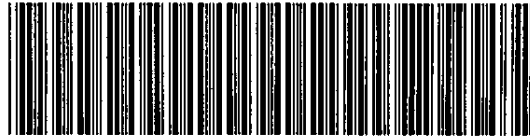

**" Amended Charter "**  
**First Church of Christ, Scientist,**  
**of**  
**Miami, FL**  
**(As amended May 1, 2016)**

Art I The name of this corporation shall be "First Church of Christ, Scientist, of Miami, Florida", and shall be located in Miami-Dade County, FL

Art. II The purpose of this corporation is to establish and maintain a Christian church in general and a First Church of Christ, Scientist, of Miami, FL in particular, to be conducted according to the rules of said church, and in accord with certain rules of The First Church of Christ, Scientist, in Boston, MA. This corporation shall have the power to possess, purchase, hold, enjoy, and receive by gift, devise or otherwise, real and personal property, chattels, monies, annuities, and effects; to erect a building or buildings or to lease same and keep in good repair; to contract and be contracted with; to rent, sell, mortgage, and dispose of its real and personal property as it may desire or deem to be in its best interest; and to do anything necessary or expedient for the carrying out of the objectives of this corporation.

Art III Any person who is a member, or shall become a member of First Church of Christ, Scientist, of Miami, Florida, shall be a member of this corporation.

Art IV This corporation shall have a perpetual existence.

Art VI The affairs of this corporation shall be managed by a Board of Trustees under the terms of the corporation By-Laws.

Art VII The Charter and By-Laws of this corporation shall be made, altered, or rescinded by the members of this corporation and shall conform to the Manual of The First Church of Christ, Scientist, in Boston, MA.

Art VIII The maximum indebtedness or liability of this corporation may at no time be greater than two-thirds of the value of the assets of the corporation at the time of incurring debt.

Art IX In the event of dissolution of this corporation, by vote of the members, the assets of this corporation shall be distributed in one or more of the following ways or combinations:

1. To one or more Christian Science branch churches.
2. To one or more accredited Christian Science Nursing Facilities.
3. To The First Church of Christ, Scientist, in Boston, MA.
4. To any Christian Science organization whose mission is in overcoming developmental challenges thru Christian Science?
